- 2. GST: GST @ 18% will be paid extra.
- 3. **Delivery**: The above items should be delivered to NIOT within 4-6 weeks from the date of receipt of order.
- 4. Payment: 100% Payment will be made after supply and acceptance of the materials through E-Payment, for which, you are required to send the enclosed format duly filled and endorsed by your banker.
- 5. Warranty: The items should carry warranty for 12 months period from the date of supply and acceptance of materials at NIOT. Warranty certificate should be provided as per the prescribed format of NIOT.
- **6. Specification**: As mentioned in NIT Document.
- 7. Part Supply: Not Allowed. All the items should be delivered in a single lot within the stipulated time.
- 8. Liquidated damages: If the Contractor fails to deliver the materials within the time specified in the Contract, NIOT shall recover from the Contractor as liquidated damages a sum of 0.5% (1/2 percent) of the contract price of the undelivered materials for each week of delay (or) part thereof. The total liquidated damages shall not exceed 5% (5 percent) of the contract price of the unit or units so delayed. Materials will be deemed to have been delivered only when all materials and parts are delivered. If any materials are not delivered in time, the entire materials will be considered as delayed upto the date of delivery the materials not delivered.
- Arbitration: In the event of any dispute, difference, interpretation or application relating to this agreement arises, the same shall be settled amicably by the parties. In case the dispute or differences could not be settled amicably, the same shall be referred for adjudication through Arbitration by an Arbitrator to be appointed by the Director, NIOT. The Arbitration shall be concluded in accordance with the provisions of Arbitration and Conciliation Act, 1996 or any statutory modifications or reenactment thereof and the rules made there under and for the time being in force shall apply to the arbitration proceedings. Venue of such arbitration shall be at Chennai in India. The language of arbitration proceedings shall be English. The Arbitrator shall make a reasoned award (the "award"), which shall be final and binding on the parties. The cost of the arbitration shall be shared equally by the parties to the contract. However, expenses incurred by each party in connection with the preparation, presentation etc., shall be borne by each part.
